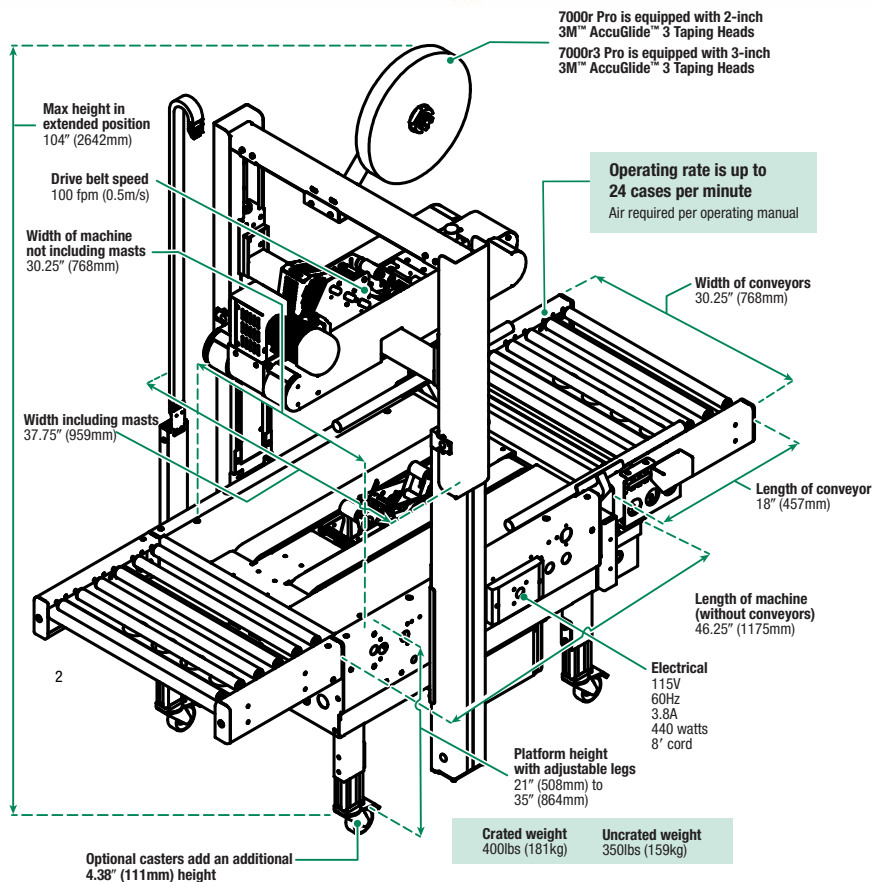

<sup>3</sup> Maximum case height of 36" can be obtained by moving the columns and upper assembly to the upper position. Minimum will be 14.625".
