Safety measures based on ATEX:

The (spare)parts/single components listed in this budget, are - unless otherwise mentioned - not intended for installation in ATEX-zone. If the plant is to be installed in accordance with ATEX, the operator of the plant has to implement a risk analysis. Additionally the operator will provide us with a risk catalogue. If the operator wishes to implement additional security measures, we will provide a budget/cost overview on his request. The same applies for measures relating to depressurizing and decoupling of conveyors.

Ex Works Hilden, unpacked without assembling, approx. 12 - 14 weeks after order confirmation and clarification of all commercial and/or technical questions as well as receipt of down payment on our account.

Payment:

30 % of the total contract price: down payment with receipt of a respective invoice based on this budget / cost overview.

70 % of the total contract price: before delivery with notice of readiness of the goods.

Reservation of title:

We remain the owner of all (spare)parts/single components listed in this budget until receipt of all outstanding amounts. The customer shall not be permitted to sell, to remove or to mortgage the affected (spare)parts/single components without our prior written consent.

Time delays:

Delays outside of our control allow an extension on the basis of all subsequent periods. If the delays are more than 2 months, we are entitled to demand 50% of the payments in our favor in accordance with the original agreement. If the delays are longer than 4 months, we are entitled to demand full payment on basis of the original agreement.

Validity:

8 weeks. We reserve the right to make price adjustments in case of an increase of raw material prices and labor services between the date of this budget and the receipt of raw materials and/or provision of services and labor.

Warranty:

The warranty period for the parts/single components is 12 months commencing with the day of delivery or notification of readiness for delays caused by the customer. Spare- and wearing parts as well as damages caused by improper operation or handling, excessive stress, over-voltage, defective/wrong equipment, alterations, inadequate repair/maintenance are excluded from warranty. Also no liability is given for defects delayed/displayed by the customer and/or by third parties for goods/services. Further warranty claims are excluded. This applies in particular for indirect and/or consequential damages, such as e.g. loss of production and loss of profit. For the promised features we can only accept warranty if the operating conditions are met. Furthermore the supplied components must be installed, operated, controlled and maintained in accordance with our operating and maintenance instructions.

Technical changes:

We reserve the right to do technical changes which influences neither the function nor the capacity of the system.

Documentation:

Operating and maintenance instructions as well as eventually necessary spare parts lists, diagrams and possibly other documentation of inserted foreign units are in German or English language. If the documentation is needed in another language, we ask for timely notification. Translation costs will be charged pro rata.

We only contract on the basis of our General Terms and Conditions of Sales and Delivery as well as on the basis of our Installation Conditions, which you can find on www.muench-gmbh.net. On request we are also pleased to send you our general Terms and Conditions of Sales and Delivery as well as our Installation Conditions by fax or mail. The goods remain our property until the final payment. Place for all legal settlements is Düsseldorf.
