BROKER-SHIPPER AGREEMENT

1. PARTIES

This Agreement is entered into between Rebuy Equipment Enterprises LLC ("Broker") and the undersigned Shipper.

2. AUTHORITY & COMPLIANCE

Broker operates under 49 U.S.C. §13904 and 49 CFR Parts 371, 386, 387, and 390-399. Broker is not a motor carrier and does not take possession of freight.

3. SERVICES

Broker arranges transportation services through authorized motor carriers and issues written rate confirmations.

4. SHIPPER RESPONSIBILITIES

Shipper warrants all freight descriptions, weights, dimensions, and handling requirements are accurate. Costs arising from inaccuracies remain Shipper's responsibility.

5. CLAIMS & LIABILITY

Claims must be filed directly with the carrier under 49 U.S.C. §14706. Broker's liability is limited to brokerage fees earned.

6. PAYMENT TERMS

Invoices are due per agreed terms. Late payments may accrue 1.5% monthly interest.

7. NON-CIRCUMVENTION

Shipper shall not tender freight directly to carriers introduced by Broker for twelve (12) months.

8. GOVERNING LAW
