* Upon processing of your contract and payment, we will email you a confirmation and receipt.

Full payment is due with the return of your contract to guarantee your priority haul out time & space.

Unused payment will be applied to your 2026 Winter Storage charges/work or can remain on your account in the event of a future storm.

Hurricane deposits will remain on your account for two (2) seasons/winters. If not applied to storage/work by 12/2028, deposits will be forfeited.

- * In the event of a storm, pre-paid boats will be given priority and time slots for their hauling.
- * Jersey Cape uses the NOAA projections to commence scheduling and hauling of vessels. It is up to you to contact
- * Jersey Cape at least 3 days prior to projected landfall to coordinate a haulout and time slot.
- * Vessels not contracted will be hauled on a first come-first serve basis as time and safety allow
- * Vessels will **not** be pressure washed, outriggers nor canvas removed by Jersey Cape.
- * Vessels not relaunching, may be re-blocked and pressure washed as part of their standard winter storage.
- * **Pricing for non-contracted storage will increase by \$ 2.00 per foot, per day, at issuance of Hurricane Warning**
- * **Contact your insurance carrier and let them know you have pre-arranged for the haul out of your boat in the event of a Hurricane as many insurance companies offer a premium discount and/or reimbursement of haul out fees**
