1. All boat trailers under this contract will have River's End Marina/Racine Riverside Marine provided identification tags attached to the tongue.
****WHEN DELIVERING YOUR BOAT TO THE YARD YOU MUST CONTACT THE OFFICE AND WE WILL ATTACH THE I.D. TAG****
*****All trailers not properly tagged will be locked or removed from the property*****
2. PAYMENT FOR SUMMER SEASON IS DUE IN FULL BY THE TIME THE BOAT IS BROUGHT INTO THE YARD.
3. River's End Marina/Racine Riverside Marine will provide a space for the boat and trailer described above and unlimited use of launch ramp from May 15, 2026 through September 30, 2026.
4. There will be a 1.5% monthly service charge on all unpaid accounts.
5. Absolutely no boat shall remain in the water unattended. Any boat left unattended overnight will be hauled out at owner's expense. The launch ramp MUST remain open for active launching and loading. Contact the office regarding use of a transient slip for overnight dockage.



6. The handling of the boat is the owner's responsibility and owners must have liability insurance. No insurance is carried by River's End Marina/Racine Riverside Marine on customers' boats, equipment or other property. Storage and dockage thereof are accepted at the risk of the boat owner and the owner hereby releases River's End Marina/Racine Riverside Marine from any and all claims.
7. The boat owner, guests and/or agents agree to comply with all the rules and regulations of this marina. River's End Marina/Racine Riverside Marine reserves the right to cancel any boat owner's contract and return the pro-rated balance of storage to the customer for not obeying the rules. By signing this contract, owner agrees to abide by said rules and regulations.
8. No outside competitive labor allowed in our yard. All work, other than what shall be done by the owner, shall be done by Racine Riverside Marine/River's End Marina unless otherwise authorized by written consent of Marina management.
9. Racine Riverside Marine/River's End Marina reserves the right to move any space assignment to accommodate the greatest number of boats.
10. All docks and walkways are to be kept clear of obstacles at all times. Inflatable boats/RIBs are to be kept on boats or in the water. All furniture and boater belongings are to be kept in boats when not in use.
11. No "FOR SALE" signs may be placed on any boat or other property without written consent of marina management.
12. Any boat deemed "abandoned", meaning the owner cannot or will not move vessel, or cannot be reached by phone, mail, or email after this contract ends may be moved, and a storage lien put on boat. The owner may be charged labor and expenses for the undertaking of this procedure. Any boat, abandoned boats or trailers left after 30 days of the end of this contract will become the property of Racine Riverside Marine, unless prior arrangements are made.

READ CAREFULLY AND NOTE THIS ON YOUR PERSONAL CALENDAR!!!!

This contract ends September 30, 2026. Any boats or trailers remaining in the building or yard after September 30, 2026 must have a valid winter storage contract or additional storage fees will be charged.
