What to know when purchasing a unit from a private seller.

Obtain pre-qualification for a loan, if needed.

This is important as you don't want to find your dream unit and miss out on the purchase because the funds to purchase it weren't available in time.

We have partnered with several lenders to provide you with financing options. We have included the full list in the Buyer Services Section below.

Verify the value of the unit.


Make sure you know the fair market value of the unit you are purchasing. This can fluctuate up or down of course if there is damage, it is a classic or has custom upgrades for example. A good way to check market value is by doing a simple Google search.

Type the year, make, model, and trim if available into a Google search and then type the words, "For sale" behind it. This will usually give you a fair range of what similar units are selling for.

Verify the history, and the condition of the unit.

Obviously most of us are used to test driving and inspecting a unit we are purchasing personally, however sometimes that is not possible. This is when the following tips can be beneficial to you.

- Purchase a vehicle history report.
 - If unable to get a history report on the unit, talking with the private seller and even looking at title records can help assure you.
- Order a unit inspection that could provide you with details to help you make the most informed buying decision.



Safe Transaction Guidance

Here are some tips to protect you when purchasing a unit.

Verify the unit.

Obtain a vehicle history report (if possible) or have a pre-purchase inspection completed. This will ensure that the vehicle identification number, and in some cases, the features listed are accurate. Talking with the seller will allow you to ask multiple questions and learn about the history of the unit as well.

Have the unit inspected

The Registry LLC always recommends a pre-purchase inspection to everyone that is purchasing something of value online.

We recommend using LemonSquad Inspection Services. They provide nationwide inspection services tailored to multiple unit types.



Never meet a seller alone

It's best to have the unit inspected or meet the seller at a public place.

Make sure you know exactly who you are sending funds too.

We recommend bank to bank wire transfers as there is a bank involved to protect all parties.

Title Transfer Information

There is some important paperwork that must be completed prior to title and funds transfer. Please reference your local DMV for any additional requirements in your State.

a. Bill of Sale: The Seller is required to complete and sign a Bill of Sale for the Buyer to take into his/her DMV in order to license the vehicle.

A sample Bill of Sale is attached at the end of this document for your use, if desired.

- **b. Title Work:** The Seller is required to date and sign the back of the title. You should also write your name on the title.
- c. The lienholder holds the title: Sometimes there is still a lien that needs to be paid when purchasing a unit from a private seller. The seller will obtain a payoff from their lienholder and provide you with the payoff amount and how to make payment to satisfy the loan. Your payment needs to be sent to the lienholder to ensure the title will be released and so that you have documentation of your purchase.
- d. **Wire Transfer:** Wire transfers are an inexpensive way to send payment, and also provides a buyer proof of payment. We recommend transferring the funds at the time transport arrives to pick up and verify the vehicle.
- e. **Checks/cashier checks:** Many scams and payment fraud exist with this form of payment. Sellers are encouraged NOT to accept this form of payment. Bank to bank wire transfer or an escrow service is recommended.
